

# Fishing Rules 2021

Kangos Association Water

**Season license**                      **SEK 300/year:** NOTE! Only land owners and permanent residents of Kangos  
**SEK 700/year:** Cabin owner at Kangos Association water  
**SEK 1100/year:** All Others

All season licenses applies as family licenses to children up to 16 years old

**24h license**                              **150 SEK / 24h** (valid as family license children up to 16 years old)

**Exceptions:**                              Only **24h license** or **season license 1100 SEK** apply to lakes Pitkäähven- and Joensuujärvi. Fishing premiere and prohibition time are displayed on signs at each lake.

Fishing ban in Leipiöjoki  
Fishing ban sea trout  
Fishing ban with live bait in the Lainio river and its tributaries  
Ice fishing not allowed in the Lainio river and its tributaries  
Fishing ban for salmon and trout in the Lainio river from September 1st  
Fishing ban for grayling in the Lainio river from September 16th

## Boat fishing

Own boats may be used by permanent residents and cottage owners in Kangos, others may only use boats that can be hired or borrowed in the area.

Boats from outside Kangos are not allowed in the Lainio river.

Boat fishing ban on the stretch from old hanging bridge - 150 m downstream of the electric power line.

Boat/pontoon boat ban in Pahturi-, Pitkäähven- and Joensuujärvi. Fishing from floating tube allowed.

Anyone with permission to fish with boat in the Lainio river must register their boat with a registration plate.

The plate is obtained via +46 70 323 78 53.

Max 3 fishing rods per boat regardless of the number of fishermen in the boat.

## Net fishing

Ban on fishing with net in the Lainio river and the smaller streams Nuuks- and Rauvosjoki.

Netfishing ban in the lakes Taka-, Pahturi, Joensuu- and Pitkäähvenjärvi. This also applies to fish traps.

In other waters, net fishing is permitted for land owners and permanent residents with a maximum net length of 90 m (3x30 m) fishing for house needs. When fishing, the net must be marked with the owner's name and telephone number.

## Bag limit

5 grayling/24h and/or 1 trout/24h in the Lainio river.

In the lakes Taka-, Pahturi-, Joensuu- and Pitkäähvenjärvi - Maximum 3 fish/24h.

Maximum 1 salmon per 24h and fisherman. Maximum 5 salmon per season and fisherman. Female salmon caught in August shall be released.

## Minimum size

Grayling 35 cm, Trout 40 cm, Salmon 50 cm.

Fish with care, so we have a good fishing tomorrow as well. Release the smaller fish carefully.

Be respectful to the cabin owners near the river and do not occupy a fishing spot. This applies to everyone; boat, spin, and fly fishermen. Camping allowed for a maximum of 3 nights in the same place.

**NOTE!** Violation of fishing rules are enforced with a control fee from SEK 500 to SEK 1000 on supervision/control. Anyone caught fishing without a valid fishing license will be reported to the prosecutor and be prosecuted for illegal fishing.
